AN ACT

AMENDING SECTION 13-1204, ARIZONA REVISED STATUTES; RELATING TO AGGRAVATED ASSAULT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 13-1204, Arizona Revised Statutes, is amended to
3 read:

4 13-1204. Aggravated assault; classification; definition

5 A. A person commits aggravated assault if the person commits assault
6 as prescribed by section 13-1203 under any of the following circumstances:

7 1. If the person causes serious physical injury to another.

8 2. If the person uses a deadly weapon or dangerous instrument.

9 3. If the person commits the assault by any means of force that causes
10 temporary but substantial disfigurement, temporary but substantial loss or
11 impairment of any body organ or part or a fracture of any body part.

12 4. If the person commits the assault while the victim is bound or
13 otherwise physically restrained or while the victim's capacity to resist is
14 substantially impaired.

15 5. If the person commits the assault after entering the private home
16 of another with the intent to commit the assault.

17 6. If the person is eighteen years of age or older and commits the
18 assault on a child who is fifteen years of age or under.

19 7. If the person commits assault as prescribed by section 13-1203,
20 subsection A, paragraph 1 or 3 and the person is in violation of an order of
21 protection issued against the person pursuant to section 13-3602 or 13-3624.

22 8. If the person commits the assault knowing or having reason to know
23 that the victim is any of the following:

24 (a) A peace officer, or a person summoned and directed by the officer
25 while engaged in the execution of any official duties.

26 (b) A constable, or a person summoned and directed by the constable
27 while engaged in the execution of any official duties.

28 (c) A firefighter, fire investigator, fire inspector, emergency
29 medical technician or paramedic engaged in the execution of any official
30 duties, or a person summoned and directed by such individual while engaged in
31 the execution of any official duties.

32 (d) A teacher or other person employed by any school and the teacher
33 or other employee is on the grounds of a school or grounds adjacent to the
34 school or is in any part of a building or vehicle used for school purposes,
35 any teacher or school nurse visiting a private home in the course of the
36 teacher's or nurse's professional duties or any teacher engaged in any
37 authorized and organized classroom activity held on other than school
38 grounds.

39 (e) A health care practitioner who is certified or licensed pursuant
40 to title 32, chapter 13, 15, 17 or 25, or a person summoned and directed by
41 the licensed health care practitioner while engaged in the person's
42 professional duties. This subdivision does not apply if the person who
43 commits the assault is seriously mentally ill, as defined in section 36-550,
44 or is afflicted with alzheimer's disease or related dementia.

45 (f) A prosecutor.

1 (g) A CODE ENFORCEMENT OFFICER AS DEFINED IN SECTION 39-123.

2 9. If the person knowingly takes or attempts to exercise control over
3 any of the following:

4 (a) A peace officer's or other officer's firearm and the person knows
5 or has reason to know that the victim is a peace officer or other officer
6 employed by one of the agencies listed in paragraph 10, subdivision (a), item
7 (i), (ii), (iii), (iv) or (v) of this subsection and is engaged in the
8 execution of any official duties.

9 (b) Any weapon other than a firearm that is being used by a peace
10 officer or other officer or that the officer is attempting to use, and the
11 person knows or has reason to know that the victim is a peace officer or
12 other officer employed by one of the agencies listed in paragraph 10,
13 subdivision (a), item (i), (ii), (iii), (iv) or (v) of this subsection and is
14 engaged in the execution of any official duties.

15 (c) Any implement that is being used by a peace officer or other
16 officer or that the officer is attempting to use, and the person knows or has
17 reason to know that the victim is a peace officer or other officer employed
18 by one of the agencies listed in paragraph 10, subdivision (a), item (i),
19 (ii), (iii), (iv) or (v) of this subsection and is engaged in the execution
20 of any official duties. For the purposes of this subdivision, "implement"
21 means an object that is designed for or that is capable of restraining or
22 injuring an individual. Implement does not include handcuffs.

23 10. If the person meets both of the following conditions:

24 (a) Is imprisoned or otherwise subject to the custody of any of the
25 following:

26 (i) The state department of corrections.

27 (ii) The department of juvenile corrections.

28 (iii) A law enforcement agency.

29 (iv) A county or city jail or an adult or juvenile detention facility
30 of a city or county.

31 (v) Any other entity that is contracting with the state department of
32 corrections, the department of juvenile corrections, a law enforcement
33 agency, another state, any private correctional facility, a county, a city or
34 the federal bureau of prisons or other federal agency that has responsibility
35 for sentenced or unsentenced prisoners.

36 (b) Commits an assault knowing or having reason to know that the
37 victim is acting in an official capacity as an employee of any of the
38 entities listed in subdivision (a) of this paragraph.

39 B. Except pursuant to subsections C and D of this section, aggravated
40 assault pursuant to subsection A, paragraph 1 or 2 or paragraph 9,
41 subdivision (a) of this section is a class 3 felony except if the victim is
42 under fifteen years of age in which case it is a class 2 felony punishable
43 pursuant to section 13-705. Aggravated assault pursuant to subsection A,
44 paragraph 3 of this section is a class 4 felony. Aggravated assault pursuant
45 to subsection A, paragraph 9, subdivision (b) or paragraph 10 of this section

1 is a class 5 felony. Aggravated assault pursuant to subsection A, paragraph
2 4, 5, 6, 7 or 8 or paragraph 9, subdivision (c) of this section is a class 6
3 felony.

4 C. Aggravated assault pursuant to subsection A, paragraph 1 or 2 of
5 this section committed on a peace officer while the officer is engaged in the
6 execution of any official duties is a class 2 felony. Aggravated assault
7 pursuant to subsection A, paragraph 3 of this section committed on a peace
8 officer while the officer is engaged in the execution of any official duties
9 is a class 3 felony. Aggravated assault pursuant to subsection A, paragraph
10 8, subdivision (a) of this section resulting in any physical injury to a
11 peace officer while the officer is engaged in the execution of any official
12 duties is a class 5 felony.

13 D. Aggravated assault pursuant to:

14 1. Subsection A, paragraph 1 or 2 of this section is a class 2 felony
15 if committed on a prosecutor.

16 2. Subsection A, paragraph 3 of this section is a class 3 felony if
17 committed on a prosecutor.

18 3. Subsection A, paragraph 8, subdivision (f) of this section is a
19 class 5 felony if the assault results in physical injury to a prosecutor.

20 E. For the purposes of this section, "prosecutor" means a county
21 attorney, a municipal prosecutor or the attorney general and includes an
22 assistant or deputy county attorney, municipal prosecutor or attorney
23 general.
